Visitation Guidelines: Letter From the Administrator:

I hope all of you are healthy and well. With fall in full swing and the kids back in school, we have seen an increase in community spread of COVID. With that increase we have had a whirlwind of changes in the guidances delivered by our governing bodies regarding outbreak, visitation, testing, quarantine, etc. Please keep in mind this is subject to change, so please be sure we have a current email address on file for you as we utilize email to communicate to our residents' family members.

Many of you have inquired as to why we have not mandated the COVID-19 vaccination for our staff. I have provided an explanation below. This is obviously a sensitive subject right now, and in no way is it my intention to politize this issue. I simply want to provide you with the background and reasoning.

Long term care is one of the most heavily regulated entities in healthcare. When it comes to COVID, we are governed by the CDC, CMS (Centers for Medicare and Medicaid Services), Wisconsin Department of Public Health, and Walworth County Public Health. President Biden made an announcement on August 18th that his administration is

mandating all staff of nursing homes be vaccinated for COVID-19. His plan is to enforce this through CMS's rules of participation. Nursing homes follow CMS rules of participation in order to be provided payment of Medicare and Medicaid funds which allows us to give care to so many seniors. Unfortunately, we have not received the guidance from CMS on mandating the vaccine. It is coming, and we expect that we will be mandating the vaccine at that time. With that being said, we have seen both vaccinated and unvaccinated staff test positive for COVID. The vaccine is not meant to stop the spread of COVID; it's meant to minimize symptoms of COVID and to reduce hospitalizations and deaths. We have definitely seen the effectiveness of this in our vaccinated staff. The vaccine absolutely has its benefits. For over a year and a half, I've asked everyone to please be patient with us as we navigate through this pandemic. I appreciate all of your patience and ask that you continue to have patience in this matter as well
